

AGREEMENT ON STUDENT EXCHANGE
BETWEEN
SCOALA NORMALA SUPERIOARA BUCURESTI
AND
JAPAN ADVANCED INSTITUTE OF SCIENCE AND TECHNOLOGY

Scoala Normala Superioara Bucuresti and Japan Advanced Institute of Science and Technology conclude this Agreement to promote student exchange between the two Institutions based upon the Agreement on the Academic Exchange between Scoala Normala Superioara Bucuresti and Japan Advanced Institute of Science and Technology.

1. Requirement for Exchange Students

Exchange students are required to be regular students registered in the Master's course or the Doctoral course at the home Institution.

2. Duration of Stay

Duration of stay for exchange students at the host Institution shall be for up to one academic year.

3. Number of Exchange Students

Each Institution may send and/or accept several students under this program each year.

4. Status of Exchange Students

The host Institution shall accept exchange students from the home Institution as non-degree candidates, who do not aim at obtaining a degree from the host Institution.

5. Acceptance Procedures

The students participating in the exchange program under the terms of this Agreement shall be selected initially by the home Institution, and the host Institution shall make the final decision on admission in each case.

6. Study Program

Each student shall determine the study program at the host Institution in consultation with academic advisors of both home and host Institutions. Depending on the study program, language requirements and/or other prerequisites may be imposed.

7. Academic Record and Accreditation

The host Institution shall evaluate the academic performance of each student according to its rules and shall send the academic record/transcript of each exchange student to the home Institution. The home Institution may give credits to students according to its regulations.

8. Tuition and Other Fees

The examination fee, matriculation fee, and tuition are waived for the exchange students.

9. Financial Responsibility

Exchange students shall be responsible for their own expenses, including travel expenses, accommodation costs, and health care fees.

10. Commencement and Duration of the Agreement

This Agreement shall go into effect on the last date of its signing by the Representatives of both Institutions and shall be in force for five years. Thereafter, it shall be automatically renewed from year to year. However, after the initial period, either Institution may, by giving six months advance written notice to the other Institution, terminate the Agreement at the end of a given year.

The terms of this Agreement may be revised or modified at any time through joint review and recommendation by both Institutions.
